### **Roles & Responsibilities**

#### **1. Policy Alignment:**

- i. Integrate UGC 2009 anti-ragging Regulations into institutional statutes and student handbooks.
- ii. Publish NO RAGGING notices prominently across campus and on official websites.

**2. Affidavit Compliance:** Collect/educate each student to provide signed affidavits/online undertakings from every student and parent/guardian via the National Anti-Ragging Portal at the start of each academic session.

**3. Awareness & Counselling**

- i. Organize induction programs, workshops, and counselling sessions to educate all stakeholders on legal, psychological, and academic consequences of Ragging.
- ii. Display anti-ragging helpline numbers (1800-180-5522) and committee contacts on notice boards and digital channels.
- iii. Display the IEC materials circulated by the Central/State governments at prominent places in the institution.

**4. Monitoring & Enforcement**

- i. Review regular reports from the Anti-Ragging Squad and take swift disciplinary action in line with UGC/NCISM norms.
- ii. Lodge FIRs for criminal offenses without exception, escalating serious cases to local law enforcement and the NCISM Monitoring Cell.

**5. Reporting & Review**

- i. Submit quarterly compliance and incident reports through the NCISM/UGC/HRD portal.
- ii. Conduct annual self-audits and peer reviews to benchmark effectiveness and update protocols.
